The International Organization for Standardization (ISO) has established an ISO 3166 name: Codes for the representation of names of countries and their subdivisions) of two-letter abbreviation codes, 3-letter abbreviation codes and numerical codes for all countries of the world (ISO 3166-1:1997), country subdivisions (ISO 3166-2:1998), and country names previously used (ISO 3166-3:1999). Below are the most common ones. It is recommended (and not only by me!) to use these standardized abbreviations in preference to any other code (especially those of vehicle license plates) to designate countries. Thus, Belgium will be designated by BE, Italy by IT, Germany by DE, Ireland by IE, the United Kingdom by GB, the United States by US.

L'Organisation Internationale de Normalisation (ISO, ou *International Organization for Standardization*) a établi une norme ISO 3166 : Codes pour la représentation des noms de pays et de leurs subdivisions) de codes-abréviations à deux lettres, de codes-abréviations à 3 lettres et de codes numériques pour tous les pays du monde (ISO 3166-1:1997), les subdivisions des pays (ISO 3166-2:1998), et les noms de pays antérieurement utilisés (ISO 3166-3:1999). Vous trouverez ci-dessous les plus usuels. Il est recommandé (et pas seulement par moi !) d'utiliser ces abréviations normalisées de préférence à tout autre code (notamment à ceux des plaques d'immatriculation des véhicules) pour désigner les pays. Ainsi, la Belgique sera désignée par BE, l'Italie par IT, l'Allemagne par DE, l'Irlande par IE, le Royaume-Uni par GB, les États-Unis par US.
